2020 Code Update Sessions

The East Central Wisconsin Association of Electrical Inspectors will again offer Code Update Sessions. You may register for one or more of the following Sessions:

(Monday) February 17 or March 23-Commercial Electrical Code -This course will cover the new electrical inspection agency requirements as well as existing commercial installations, equipment listing requirements and limitations, and transformer inspections. A code panel will cover common commercial electrical code violations.

(Tuesday) February 18 or March 24-Residential Electrical Code Update – This course will cover 2017 NEC code changes, existing wiring in pre-1978 homes, and load calculation issues. A code panel will also cover common residential electrical code violations.
